# Principles of the Libertarian Party of South Africa (LiPSA)

Adopted on 20<sup>th</sup> October 2013 at the Inaugural Party Conference of the Libertarian Party of South Africa (LiPSA) in Prince Albert.

## 1. Identity

The principles set forth in this document shall constitute the basis of the policy positions and political actions of the organization known as the "Libertarian Party of South Africa" hereinafter referred to as the Party or LiPSA.

Members of the Party may be referred to as Libertarians.

We recognize the existence of the South African Constitution as the fundamental law governing South Africa, despite its flaws.

## 2. Vision

As Libertarians, our vision is of a South Africa in which

- all individuals are sovereign over their own lives
- no one is forced to sacrifice his or her interests for the benefit of others
- citizens enjoy a world-class, globally competitive economy
- the inhabitants are free to choose as they see fit, to follow their own dreams in their own ways, without interference from government or any authoritarian power.

We believe that the only just system is that in which every person enjoys unfettered individual liberty as a natural right, limited only by the need to respect the equal right of others to such liberty. As a political party, we are committed to the objective of introducing such a system in South Africa.

We believe in the fundamental right of all individuals to have no action taken against them without their consent, provided they respect this right for others.

We defend each person's right to engage in any consensual activity and welcome the diversity that this freedom brings.

## 3. Rights and Principles

We libertarians hold that each individual enjoys four fundamental human rights, namely

- the right to life
- the right to pursue personal growth and happiness
- the right to resist actions against you to which you do not consent
- the right to own property.

### 3.1 The right to life

Every individual has the right to life and bodily integrity. No action by any other individual or group may lawfully compromise this right. Individuals have the right to resist policies, laws, or actions that abridge this right.

### 3.2 The right to pursue personal growth and happiness

Every individual has the right to use the attributes and resources of their life, their energy, intelligence and will, to improve their circumstances, provided they do not use force or fraud.

### 3.3 The right to consent

No action may be taken against law-abiding individuals without their prior, informed consent.

### 3.4 The right to property

Every individual has the right to fully own property lawfully acquired through effort, trade, inheritance, or gift. No action by any other individual or group may lawfully compromise this right. No property owned by law-abiding individuals may be taken without their prior, informed consent.

# Beginnels van die Libertynse Party van Suid-Afrika (LiPSA)

Aangevaar op 20 Oktober 2013 by die stigtingsvergadering van die Libertynse Party van Suid-Afrika (LiPSA) in Prince Albert.

## 1. Identiteit

Die beginsels soos uiteengesit in hierdie dokument sal die basis vorm van die beleid en politieke optrede van die organisasie bekend as die "Libertynse Party van Suid-Afrika" hierna die Party of LiPSA.

Lede van die party kan na verwys word as libertyne.

Ons erken die bestaan van die Suid-Afrikaanse Grondwet as die fundamentele wet van Suid-Afrika, ten spyte van die foute daarin.

## 2. Visie

As libertyne, is ons visie van 'n Suid-Afrika waarin:

- Alle individue soewerein is oor hul eie lewens.
- Niemand gedwing word om sy of haar belange op te offer ten goede van ander nie.
- Burgers 'n wêreld-klas, globale mededingende ekonomie geniet.
- Inwoners vry is om te kies soos hulle wil, hul eie drome na te volg soos hulle goed dink, sonder inmenging van enige regering of outoritêre mag.

Ons glo dat enigste regverdige stelsel een is waarin elke persoon onbelemmerde individuele vryheid geniet as 'n natuurlike reg, wat slegs deur die behoefte om die gelyke regte van andere te respekteer beperk word. As 'n politieke party, stel ons onself ten doel om die instelling van so 'n stelsel in Suid-Afrika na te jaag.

Ons glo in die fundamentele reg van alle mense om dat geen aksie teen hulle uitgevoer kan word sonder hul toestemming nie, met dien verstande dat hulle die soortegelyke regte van ander respekteer.

Ons verdedig elke persoon se reg om betrokke te raak in enige konsensuele aktiwiteit en verwelkom die diversiteit wat hierdie vryheid bring.

## 3. Regte en Beginsels

Ons libertyne hou dat elke individu geniet vier fundamentele menseregte,

- die reg op lewe
- die reg om persoonlike groei en geluk na te jaag
- die reg om stappe teen jou waarna jy nie toestem nie te weerstaan
- die reg om eiendom te besit.

### 3.1 Die reg op lewe

Elke individu het die reg op lewe en liggaamlike integriteit. Geen optrede deur enige ander individu of groep mag wettiglik hierdie reg oortree nie. Individue het die reg om beleide, wette of aksies wat hierdie reg oortree te weerstaan.

### 3.2 Die reg om persoonlike groei en geluk na te jaag

Elke individu het die reg om die eienskappe en hulpbronne van hul lewe, energie en intelligensie te gebruik om hul omstandighede te verbeter, mits hulle nie geweld of bedrog gebruik nie.

### 3.3 Die reg om toestemming

Geen aksie kan geneem word teen wetsgehoorsame individue sonder hul vooraf ingeligte toestemming nie.

### 3.4 Die reg om eiendom

Elke individu het die volkome reg om privaat eiendom wettiglik te verkry deur inspanning, handel, erfenis, of geskenk. Geen optrede deur enige ander individu of groep mag wettiglik hierdie reg oortree nie. Geen eiendom in besit van wetsgehoorsame individue kan geneem word sonder hulle vooraf, ingeligte toestemming nie.
